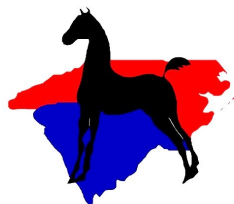

RULES & REGULATIONS

This Horse Show is conducted in accordance with the Rules of the USEF. The official Federation Rule Book will prevail for this show. Each participant in this show is responsible for knowledge of these rules and is subject to these rules. Any changes or corrections of the rules will automatically become part of this prize list. Questions that may arise that are not covered by the USEF Rule Book will be decided by the Show Committee and their decisions will be final.

North Carolina State Championship USEF Lite Competition #345286

1. Entries must be received by Monday August 31, 2026. Post entries will be accepted; an additional \$10.00 per horse will be charged. We encourage you to enter via www.horseshowsonline.com, however entries may also be mailed or emailed to horseshowentries18@gmail.com
2. **Damages—all owners and exhibitors will be held responsible for any damage incurred by them or their agents to barns or other properties on the show grounds.**
3. Stalls will be available Monday September 14—Sunday September 20, 2026 (\$175.00 per stall). Grounds fee for academy horses only (no stall) \$25.00 per horse In an effort to help us accommodate everyone we ask that you limit the number of tack stalls that you order. All stalls must be paid in advance, no later than September 8. An open check or credit card on file is an acceptable form of payment. **NO EARLY ARRIVALS.**
4. Office Fee— a non refundable office fee of \$35.00 per horse or \$15.00 per academy rider will be charged.
5. All American Saddlebred classes will be judged using the American Saddlebred breed rules for competition found at this link: https://www.saddlebred.com/application/files/1717/4118/2726/SB-v2025_0_0.pdf
6. **Attention getting devices &/or other noisemakers are not allowed in and around the make up ring or competition rings during scheduled competition sessions. Use of explosives and fire extinguishers (except in the case of fire) is not allowed on the grounds at any time.**
7. The Board of Directors of the UPHA Chapter 12 and Show Management reserve the right to refuse any entries and/or stable request before or during the show, without being liable to compensation.
8. No person will be allowed in the show ring during the time of judging except the exhibitors and those having official or requested duties to perform.
9. Exhibitors are notified that any act of discourtesy or disobedience to the judge or officials, on the part of the owner, manager, rider, driver or caretaker shall be grounds to disqualify the horse and all fees shall be forfeited.
10. All riders, drivers, attendants and caretakers shall be neatly and appropriately dressed upon entering the ring.
11. A Negative Coggins test within one year of the show must accompany each horse and must be available for inspection.
12. All checks should be made payable to UPHA Chapter 12 NCSCHS. Returned checks or declined credit cards will incur a \$50.00 handling fee. No one will be allowed to show who has a NSF check outstanding with the show.
13. The gate to the show ring will remain open two minutes after the first horse enters the ring. Any exhibitor not in the ring at that time will not be admitted.
14. The UPHA Chapter 12 Board, The North Carolina State Fairgrounds, Show, Officials, nor any sponsor will be responsible for any accident which may occur to any owner, rider, driver, caretaker, attendant, animal or equipment at the show.
15. Qualifying for any Stake or Championship class is NOT necessary. However if you decide not to qualify the entry fee for the Stake/Championship class will be based on the following—Qualifying class entry fee, plus the Championship class entry fee, plus \$25.00.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) lead-line; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; and 7) assistant handlers in Dressage Sport Horse Breeding classes.

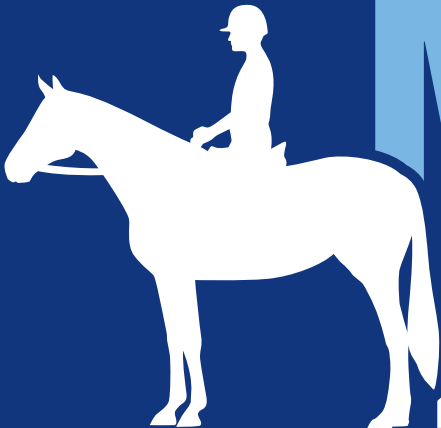
USEF Motorized Vehicle Statement

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Horse Shows Online Online Show Entry

What you need:

- A free account at HorseShowsOnline. If you don't already have an account you can create one when you click the continue button below. HorseShowsOnline basic member is FREE.
- A record in your account for each person and horse that you will use on show entry forms when you enter a show.
- **How do I get started:**
 1. Login to HorseShowsOnline by clicking the "Member Services" button in the main menu, OR click the continue button below.
 2. Once you are logged in, click the "My Horses, People, Shows" button in the member menu.
 3. At the People, Horses, Shows page, add any new people and horses to your account as required on the appropriate tab (IE: My People, My Horses). People and horses are saved with your account. Once you have those records in your account you can use them at every show you enter.
 4. Click the "Enter show" button to select the show you want to enter and follow the steps in the online entry wizard.

Steps to enter a show:

- Select the show you want to enter from your **"My People, Horses, Shows"** page on the **"My Show Entries"** tab, or find the show you want to enter in show selector and click the Online Entry icon. This will start the online entry wizard. Make sure you have already created the horses and people in your member account.
- The online entry wizard will guide you through the steps to complete the entry form. The basic steps in the wizard are:
 1. Select the horse, people, and riders for your entry
 2. Select the classes each rider is entered in.
 3. Select the quantity for stalls and other fees.
 4. Confirm your selections
 5. Checkout and submit the show entry.
- The final step generates the completed entry form and submits your entry to the show for review and acceptance. If the show requires a payment at entry time, you will be prompted for your credit card information.

Tips:

- You can cancel the entry part way through the wizard and resume the entry later on. For example if you need to add more people to your account, or you just want to come back and complete the entry later. Unfinished entry forms are listed in your "My entries" tab and will allow you to edit the entry.
- People and horses you create in your account are saved permanently and can be used in other shows you enter. You only need to add people and horses once and then they can be re-used.

UPHA Chapter 12 is proud to be sponsoring the Single Bit Classes for 2026.

Here are the details for the Single Bit Classes that have been added at the shows listed below. These rules are slightly different than the Midwest shows and other OTAB snaffle bit classes.

Single Bit Division:

Single Bit classes are Open to Any Breed and for Amateur and Juvenile riders in a snaffle bit only (no curb bits or curb chains allowed), with a running martingale, German martingale or draw rein. All tack should be of show ring quality. Riders are to wear appropriate show ring attire. Horse/rider combinations may not cross enter into another division, with the exception of the Model, Showmanship and Pattern classes, unless otherwise stated in the prize list.

The same horse/rider combination may not compete in both WT and WTC sections of the Single Bit division at the same horse show.

Horses competing in the single bit division are generally not allowed to show in a full bridle at the same show, with the exception being the equitation division. Horses may cross enter into the equitation, model, showmanship and academy classes.

Riders can cross enter in other divisions, except Academy, but not with their single bit horse.

You may not show in WT if you have ever cantered.

Horses are judged on performance, manners, presence, quality and conformation while exhibiting a flat walk, trot and canter and are expected to stand quietly.

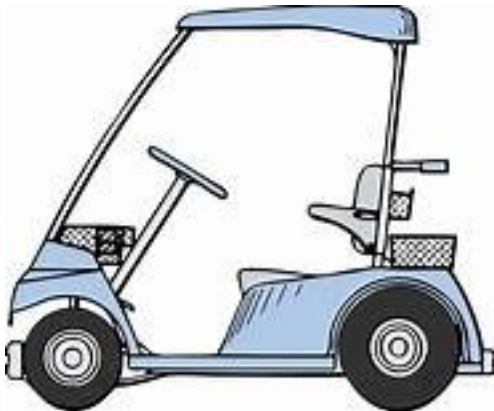

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.
